

**Undertaking given to the Principal (Head of Institution),**  
**Pushpagiri Institute of Medical Sciences & Research Centre, Tiruvalla.**

(To be signed by every student, his/her parent/guardian at the time of admission and before the commencement of every educational year (Vide Supreme Court guidelines issued following writ petition (Civil) No. 656/1998 of SCI) and The Kerala Prohibition of Ragging Act 1998 Section 2B).

I am aware that, there is an act called '**Kerala Prohibition of Ragging Act**'. Under this act,

1. Ragging means (a) Doing any act, by disorderly conduct to a student of an educational institution whether by words spoken or written.  
(b). An act which has the effect of teasing, treating or handling with rudeness any student, abusing or playing practical jokes or causing hurt, indulging in rowdy or undisciplined activities which causes or is likely to cause annoyance, hardship or psychological harm or to raise fear or apprehension thereof in a student.  
Asking any student to do any act or perform something which such student will not do in the ordinary course and which has the effect of causing or generating a sense of shame or embarrassment so as to adversely affect the physique or psyche of a fresher or a junior student.
2. Ragging is a reprehensible act which does no good to anyone.
3. No act of ragging shall be tolerated, got unnoticed or unpunished.
4. Ragging in any form is banned in and outside the institution.
5. Any one found indulging in ragging activities will be punished on conviction punishment with imprisonment for a term which may extend upto two years and fine upto Rs:10,000/-. The punishment may include expulsion / suspension from the institution or classes for a specific period or line with public apology, withholding scholarship or other benefits, debarring from representation in events, withholding results. Suspension of expulsion from hostel or mess and the like. Any student convicted of an offence shall not be admitted in any other educational institution for a period of three years.
6. Even if individuals committing or abetting ragging are not identified collective punishment may be resorted to.
7. Migration Certificate issued by the institution will contain an entry apart from that of general conduct and behaviour whether the student had participated in and or was punished for ragging.

I undertake that I / my ward will not indulge or abet in any activity which could amount to ragging during the period of my study till the completion of my course. I will ensure that I / my ward will not conduct myself/himself/herself in any way that is likely to promote or propagate any activity within or outside the institution which could amount to ragging during the period of my/his/her study or completion of my/his/her course whichever is later.

I am also aware that if the act committed amounts to any unlawful offence, the same will be reported to the police without any notice for appropriate action.

I have fully understood the implications of signing this undertaking and I am aware that I / my ward will be punished appropriately if found guilty.
